Introduction

One of the most fascinating aspects of my role was the challenge of defending and promoting my country's position in a highly technical and politically charged debate. I had to carefully craft arguments, propose amendments, and negotiate with other delegates to gain support for my proposals. This was a major achievement, considering the complexities of coalition-building and the need to continuously adjust my proposals to accommodate different viewpoints. Beyond the policy discussions, EuroSim also provided an opportunity to connect with participants from across Europe and the United States, exchanging ideas and building friendships along the way.

Looking back, this experience pushed me far beyond my comfort zone. It tested my ability to articulate complex ideas, adapt my negotiation strategies, and improve my public speaking skills under pressure. Most importantly, it reinforced my appreciation for diplomacy and the art of policymaking.

Preparation Phase

The preparation sessions for EuroSim 2025 were both fascinating and incredibly helpful. They not only provided me with the knowledge I needed about the simulation's structure and topics but also prepared me for the practical challenges I would face in Antwerp. My colleagues frequently asked me challenging questions, forcing me to think quickly and respond convincingly. I genuinely enjoyed this aspect, as it made the sessions both engaging and intellectually stimulating. Additionally, after each session, we received feedback, which was crucial for improvement. I paid close attention to this feedback and actively worked on refining my responses, adjusting my communication style, and improving my ability to think on my feet.

At the beginning, adapting to this political setup was difficult. I was stepping into discussions on topics I wasn't deeply familiar with, and it felt overwhelming at times. However, this challenge pushed me to research more, to understand the mechanics of EU politics, and to refine the way I spoke and presented arguments. Over time, I noticed significant growth in myself. I became more confident, more strategic in my communication, and better at handling conflicts in a diplomatic way.

Looking back, the preparation sessions were instrumental in shaping my EuroSim experience. They not only helped me succeed in the simulation but also equipped me with skills that will be valuable beyond this event, in both my academic and professional future.

Simulation Experience & Outcomes

My preparation for the simulation started with an in-depth study of my alter ego, Simonas Gentvilas. This strategic approach was essential in ensuring my amendments had a realistic chance of passing.

Representing my university at such an important event was a source of great pride, and I was determined to contribute meaningfully to the discussions.

In my working group, the debates were dynamic and sometimes intense. I began by carefully observing the personalities in the room, assessing how they approached negotiations and where their interests lay. Almost every discussion saw my active participation—I made sure to present

my views clearly and concisely, ensuring that my arguments were easy to understand and persuasive. Outside the formal sessions, I took advantage of unsupervised meetings to personally approach delegates, explain my amendments, and build support for my proposals. These one-on-one conversations were crucial in securing votes, as they allowed me to tailor my arguments to each delegate's priorities.
